**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
JACKSONVILLE GREYHOUND RACING CIRCUIT, INC.**

Pursuant to Chapter 607.1006, Florida Statutes, **JACKSONVILLE GREYHOUND RACING CIRCUIT, INC.**, a Florida corporation (the "Corporation"), does hereby amend its Articles of Incorporation to change its name as follows:

1. Article I of the Articles of Incorporation of the Corporation is hereby repealed in its entirety and the following is substituted therefor:
