# ARTICLES OF INCORPORATION OF SOUTHWEST FLORIDA EQUIPMENT, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

#### ARTICLE ONE NAME

The name of the corporation is SOUTHWEST FLORIDA EQUIPMENT, INC.

#### ARTICLE TWO PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1315 N.W. 2nd Street, Homestead, Florida 33030.

## ARTICLE THREE CORPORATE DURATION

The duration of the corporation is perpetual commencing with the filing of these Articles with the Florida Secretary of State.

## ARTICLE FOUR PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- 2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.


