The undersigned, as Incorporator of GEO-LINK AMERICAS, INC., adopted the below-detailed amendment to the Articles of Incorporation at a special meeting held on April 29, 1999. 1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:
