In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **PELLETIERE FAMILY CHIROPRACTIC, P. A.**

ARTICLE II

The purpose for which this corporation is organized is the practice of chiropractic medicine and related services.

ARTICLE III

The existence of the corporation shall begin upon filing.

ARTICLE IV

ARTICLE V

The corporation shall have the authority to issue 1000 shares of Common Stock, in one class only, each with a par value of \$.01. The incorporator of this corporation is Michele Pellicciere whose street address is 9895 Citadel Ln., #207, Bonita Springs, Florida 34135.

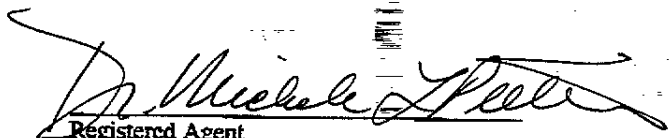
