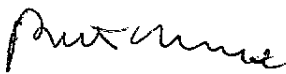

ARTICLE I - NAME

The name of this corporation is CRC DATA TECHNOLOGIES, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on March 25, 1999.

ARTICLE III - PURPOSE

This corporation is organized for the purpose to for computer sales, service and consulting and for transacting any or all-lawful business as allowed under the laws of Florida.

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

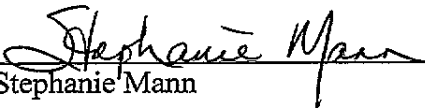
ARTICLE X - ACTION BY DIRECTORS WITHOUT A MEETING

This corporation reserves the right to amend or repeal any amendment hereto, and any right, conferred upon the shareholders is subject to this reservation.

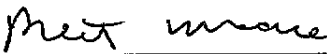

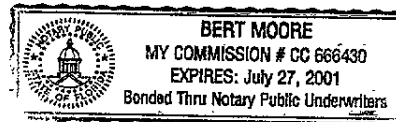
