ARTICLE V - INITIAL PRINCIPAL OFFICE

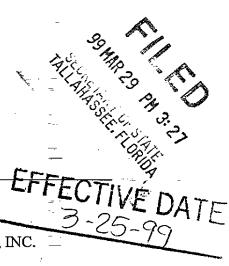
