

ARTICLES OF INCORPORATION OF

ARTICLE I.
CORPORATE NAME

The name of this corporation shall be: NUDAROM CORP.



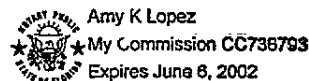


