The undersigned, being a natural person of the age of more than twenty-one gears; does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation ("Corporation") shall be Genova and Associates, Inc.

The principal place of business of this corporation shall be 11643 Chariot Lane, Jacksonville, Duval County, Florida 32223.
