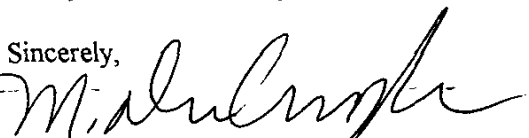
We are submitting our 2000 UBR today as soon as we were informed that we have yet to file this report. We are submitting a check for \$ 150.00.
