ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: The name of the corporation shall be Marmijon, Inc.

Article II: The principal place of business and mailing address of this corporation shall be 2050 N.E. 151st Street, North Miami, Florida 33162.

Article III: The number of shares of stock that the corporation is authorized to have outstanding at any one time is 7,500, all of which are of a par value of one dollar each and classified as Common shares.

Article IV: The name and address of the initial registered agent is UCC Filing & Search Services, Inc., 526 East Park Avenue, Tallahassee, Florida 32301.
