**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF

The undersigned, as President of GEI CAPITAL HOLDINGS XI, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act (the "ACT"), states as follows:

1. The current name of the Corporation is GEI CAPITAL HOLDINGS XI, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation was April 26, 1999.
3. The Original Articles were amended by the filing of that certain Amendment to Articles of Incorporation filed with the Florida Secretary of State on July 21, 1999 (the "Amendment to the Articles"). The Original Articles and the Amendment to the Articles are hereinafter collectively referred to as the "Articles of Incorporation".
4. The Articles of Incorporation of the Corporation are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

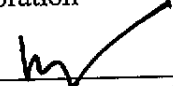
ARTICLE I - NAME

The name of this corporation is CED CAPITAL HOLDINGS XI, INC.
