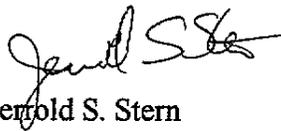

**ARTICLES OF INCORPORATION  
OF  
MUNDT BUSINESS ENTERPRISES, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Mundt Business Enterprises, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be 1450 Royal Poinciana Drive, Sanibel, Florida 33957, and the mailing address shall be the same.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100, consisting of one class only designated as "common stock," with par value of \$1.00 per share.

ARTICLE IV INITIAL REGISTERED AGENT AND ADDRESS

The period of its existence is perpetual.
