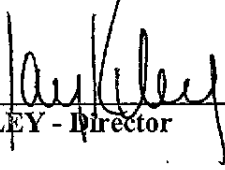
ARTICLE I.

3.) This Amendment has been duly adopted and executed by the Board of Directors on this 29th day of April, 2002.

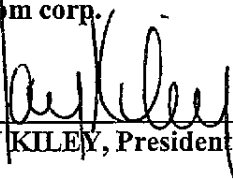
