ARTICLES OF INCORPORATION  
OF  
FIVE STAR PACIFIC ENTERPRISES, INC.

ARTICLE I - NAME

The name of this Corporation is FIVE STAR PACIFIC  
ENTERPRISES, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual duration.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any  
activities or business permitted under the Laws of the United  
States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is  
authorized to have outstanding at any time is 100 shares of common  
stock having a par value of \$1.00 per share.

ARTICLE V - INITIAL REGISTERED  
OFFICE AND AGENT

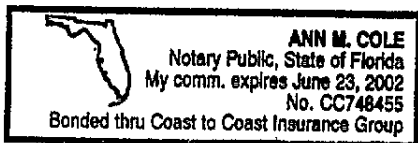
