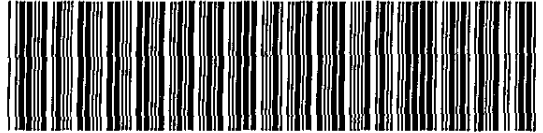

The name of this corporation shall be Global World Network Securities, Inc.

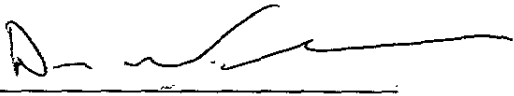
**Article III
