

The undersigned, for purposes of amending the Articles of Incorporation of R & D Printing Center, Inc., does hereby file and adopt the following Articles of Amendment:

1. The name of the corporation is R & D Printing Center, Inc. The Articles of Incorporation were filed on May 10, 1999 and assigned document number P99000043892.
