**ARTICLES OF INCORPORATION
OF
IMRGLOBAL OXFORD CORP.**

The undersigned, acting as incorporator of IMRglobal Oxford Corp., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:
