ARTICLES OF INCORPORATION

OF

MID FLORIDA PRIMARY CARE PHYSICIANS ASSOCIATES, P.A.

The Undersigned, acting as incorporator of a corporation under the Florida General Professional Service Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is MID FLORIDA PRIMARY CARE PHYSICIANS ASSOCIATES, P.A.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

<u> ARTICLE III - NATURE OF BUSINESS</u>

The purpose for which the corporation is organized is the practice of medicine.

ARTICLE IV - STOCK

Number. The aggregate number of shares that the corporation shall have the authority to issue is 100 shares of Capital Stock.

<u>Initial Issue</u>. Ten (10) shares of Capital Stock of the corporation shall be issued.

Stated capital. The sum of the issue value of all shares of Capital of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

<u>Dividends</u>. The holder of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.


