

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation.

ARTICLE ONE

NAME

The name of the corporation is ACORN, INC..

DURATION

The term of existence of the corporation shall be perpetual.

PURPOSE

This corporation shall be deemed to commence existence on the 17th day of May, 1999, or as otherwise required under the Florida Business Corporation Act.






