ARTICLES OF INCORPORATION OF GOLDFINGER'S SOUTH, INC.

I, the undersigned, hereby subscribe to, acknowledge and file the following Activities of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is: GOLDFINGER'S SOUTH, INC., a Florida corporation.

ARTICLE II - PURPOSE
