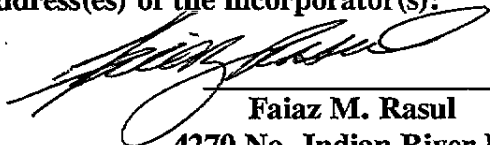
ARTICLE VII. BOARD OF DIRECTORS

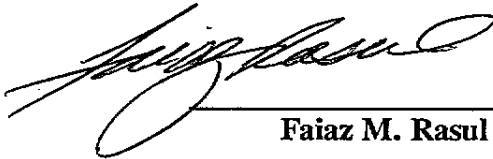
