AGREEMENT AND PLAN OF MERGER

AGREEMENT AND PLAN OF MERGER, dated as of August 20, 2007, between Equity One (Concord) LLC, a Florida limited liability company ("Concord") and Equity One (Florida Portfolio) Inc., a Florida corporation ("BOFP" or the "Surviving Corporation").

Concord and EOFF desire to effect the statutory merger of Concord with and into EOFF, with EOFF to survive such merger.

- 1. <u>Constituent Company</u>. Concord and EOFP shall be parties to the merger (the "Merger") of Concord with and into EOFP.
- 2. Terms and Conditions of Merger. Concord shall, pursuant to the provisions of the laws of the State of Florida, be merged with and into BOFP, which shall continue to exist pursuant to the laws of the State of Florida. Upon the effective date of the merger, as set forth in paragraph 7 (the "Effective Date"), the existence of Concord shall cease. On the Effective Date, EOFP shall assume the obligations of Concord.
- 3. <u>Conversion of Shares</u>. Upon the Effective Date, the Membership Interests of Concord presently issued and outstanding shall be retired. Upon the Effective Date, each share of capital stock of EOFP that is issued and outstanding immediately prior to the Effective Date shall continue to be outstanding at and after the Effective Date as shares of the Surviving Corporation.
- 4. Articles of incorporation. The Articles of Incorporation of EOFP as of the Effective Date shall be the Articles of Incorporation of the Surviving Corporation and shall continue in full force and effect, until changed, altered or amended as therein provided and in the manner prescribed by the laws of the State of Florida.
- 5. <u>Bylaws</u>. The Bylaws of EOFP as of the Effective Date shall be the Bylaws of the Surviving Corporation and shall continue in full force and effect, until changed, altered or smended as therein provided and in the manner prescribed by the laws of the State of Florida.
- 6. <u>Directors and Officers</u>. The directors and officers of the EOFP in office on the Effective Date shall continue to be the directors and officers of the Surviving Corporation, all of who shall hold their directorships and offices until the election and qualification of their respective successors or until their terms is otherwise terminated in accordance with the Bylaws of the Surviving Corporation.
- 7. Effective Date. The Merger shall become effective on the date on which the Articles of Merger have been filed with the Secretary of State of the State of Florida.
- 8. Amendment and Plan of Merger. The Board of Directors, the Shareholders and the Members, as applicable, of each of Concord and BOFP, are authorized to amend this Plan of Merger at any time prior to the Effective Date.
