ARTICLES OF INCORPORATION

<u>ARTICLE I</u>

Name, Address and Duration

The name of the Corporation is Sunshine Recycling, Inc. The address of the principal office of this Corporation is 230 Crown Oak Centre Drive, Longwood, Florida 32750 and the mailing address of the Corporation is the same. The duration of the Corporation is perpetual.

ARTICLE II

Registered Office and Agent

ARTICLE III

Corporate Purposes, Powers and Rights
