FIRST: (A) Article I. of the Articles of Incorporation is hereby amended to change the name of the corporation to the following: **RICHARD RALPH VANATTA, P.A.**

(B) i Article V. is hereby amended to delete the Heading "Principal Office" and insert the Heading "Registered Agent".

(C) i. Article VI. heading (as to the second printed VI.) is amended due to a typographical error and changed to VII.

DELETED ~~ii. Article VI. (as to the second printed VI.) of the Articles of Incorporation is hereby amended to delete the incorporator known as JONNIE VANATTA, of 2664 Slow Flight Drive, Daytona Beach, Florida 32124.~~

(D) Insert new paragraph VIII. The address of the principal office is 2644 Slow Flight Drive, Daytona Beach, Florida 32124.
