**ARTICLE I-Name**

The name of this corporation is F & C Irrigation, Inc.

**ARTICLE II- Principal Office**

The address of the principal office is 7 South Egret Street, Sebring, Florida 33872.

**ARTICLE III-Duration**

This corporation shall have perpetual existence.

**ARTICLE IV-Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE V-Capital Stock**

This corporation is authorized to issue 7000 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".



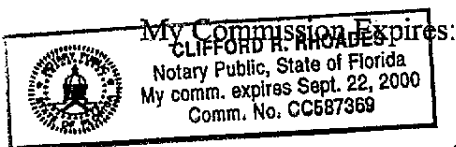
