## ARTICLES OF INCORPORATION OF BARBARA VITTORIA, LCSW, P.A.

#### ARTICLE I

#### ARTICLE II

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

#### ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz: & rending service as a psychopheratist, and a clinical social worker.
