ARTICLE I - NAME

The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

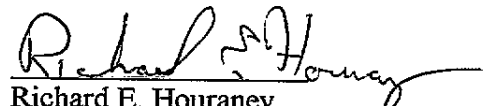

ARTICLE X - AMENDMENT

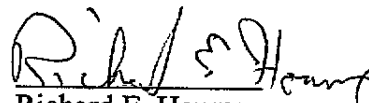
This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.

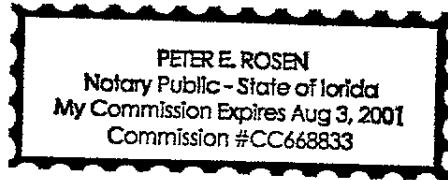
