Name**

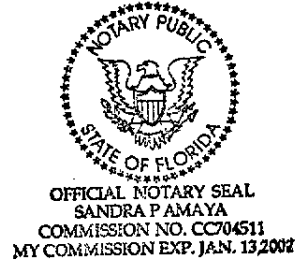

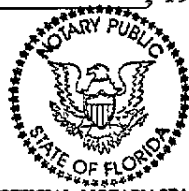
