I am writing this letter concerning the taxes that I owe through my business. I understand that I am very late with the information that you have requested and deeply apologize for that. In all honesty, I had no idea that I was suppose to send anything in partially because I never received the first notice in the mail. Last year I had employees that helped with things like this. As much as I hate to give excuses and reasons, I must do so in order that you may understand the situation.

I closed my retail store last fall in which I decided to work alone out of my home. In doing so, I changed my mailing address as the post office had requested as well as resubmitted the request this past spring when I realized I was not receiving all my mail. Although this was done, I still did not receive all my mail, which included important tax information such as what you requested. Unfortunately, the mail has become even more confusing and misplaced by the postal service because both my mother and I go by Margaret Allcorn. My mother lives at a different address so some of the mail ends up going to her.

Last year I became a severe victim of credit fraud in which I closed many false accounts that in time have ruined my credit that used to be perfect until someone took advantage of me so I cannot operate on line and I have an enormous amount of junk mail. After spending hours of time closing false accounts running a small business, and loosing lots of money in-the-long-run because-of-a bad lease-on-my building, I sublet my retail space due to the overwhelming stress at twenty five years old. I have not paid myself a salary in almost a year. My parents and friends support me as I still operate a floral business for weddings and parties to pay bills.

Again, I apologize for giving so many pitiful excuses as to why this is late and why I hope to not be penalized for it. I pay my taxes honestly and I am doing the best I can as I hope to restructure my business to be profitable. Thank you for your consideration and understanding.
