ARTICLES OF INCORPORATION

Of

ASHFORD SERVICES INC.

The undersigned incorporator, H. Casey Harter, adopts the following Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is ASHFORD SERVICES INC.

ARTICLE II DURATION

This corporation shall exist perpetually, commencing on the date of the filing of these Articles of Incorporation by the Incorporator in the Office of the Secretary of State of the State of Florida.

ARTICLE III NATURE OF BUSINESS

This corporation is organized for the purpose of transacting and engaging in any or all business permitted under the laws of the United States, the State of Florida and

all other states, territories and jurisdictions of the United States.

ARTICLE IV CAPITAL STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one hundred shares of common capital stock having a par value of One Dollar per share.

ARTICLE V INITIAL PRINCIPAL OFFICE AND INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI DIRECTORS

ARTICLE VIII FIRST OFFICERS

ARTICLE IX BYLAWS

RESTRICTIONS ON TRANSFER OF STOCK

Any Director may also serve the corporation in any other capacity and receive compensation therefor in any form.

ARTICLE XII INDEMNIFICATION

The Board of Directors is hereby specifically authorized to make provisions for the indemnification of Directors, Officers, Employees and Agents of the corporation to the full extent permitted by law.

ARTICLE XIII SHARES WITHOUT CERTIFICATES

The Board of Directors may authorize the issuance of some or all of the shares of any or all classes of stock without certificates. The Board of Directors and the corporation shall have all authority given under Section 607.0626(1) and (2), Florida Statutes, as the same now exists or may exist from time to time.
