# ARTICLES OF INCORPORATION

OF

# ARTICLE I.

# NAME

The name of this corporation is Degesys Diagnostic Services, Inc.

# ARTICLE II.

# PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is 5200 Brittany Drive South, #1202, St. Petersburg, FL 33715.

# ARTICLE III.

# DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of June 25, 1999.

# ARTICLE IV.

# <u>PURPOSES</u>

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

# ARTICLE V.

# CAPITAL STOCK
