ARTICLES OF INCORPORATION OF STEINER U.S. HOLDINGS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of the corporation is STEINER U.S. HOLDINGS, INC. (hereinafter called the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
