NAME

The name of this corporation is: ATP Management Corp.

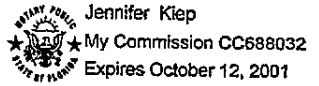

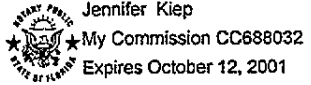
