

ARTICLES OF INCORPORATION

OF

CONCEPT COUNSELING & HYPNOTHERAPY, INC.

ARTICLE ONE

The name of the corporation is CONCEPT COUNSELING & HYPNOTHERAPY, INC. The principal address of the corporation is: 12199 N.W. 32nd Place, Coral Springs, Florida 33065.

The period of its duration is perpetual.
