- (a) To engage in and carry on the practice of accounting as a professional corporation and to own and operate an accounting clinic for the purposes of providing accounting services.
- (b) To engage in every aspect and phase of the business of rendering accounting and tax services to the general public and to do all things in connection therewith that are customarily done by licensed Certified Public Accountants under the laws of the State of Florida and in accordance with Chapter 621, Florida Statutes, "The Professional Service Corporation Act". Provided, however, that such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice said profession therein.
