ARTICLE I

NAME

The name of this corporation is 403 Atlantic Blvd., Inc.

ARTICLE II

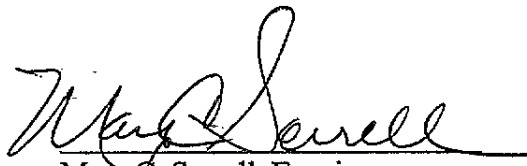
ARTICLE VIII

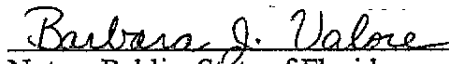

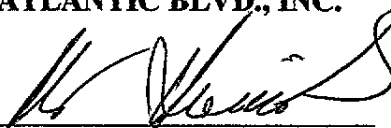

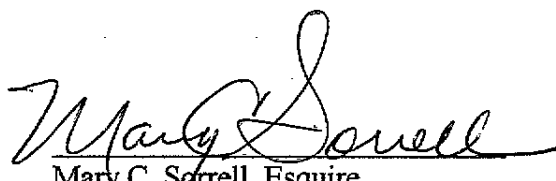
