**ARTICLES OF INCORPORATION**

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby makes, subscribes and acknowledges these Articles of Incorporation in accordance with the laws of the State of Florida.

**ARTICLE I**

The name of this corporation is **GREEN FIELD FARMS, INC.**

**ARTICLE II**

The nature of the business and the objects and purposes proposed to be transacted by the corporation are:

1. To carry on the business of farming, dairying, and of producing, merchandising, manufacturing, and preserving all kinds of farm, dairy, and meat products, and to carry on all other business incident thereto or connected therewith.

2. To purchase, manufacture, and sell, both at wholesale and at retail, milk and dairy products, and also to sell food products at wholesale and retail. The corporation shall also be authorized to purchase real estate and personal property, and to do any and all things necessary to the successful and profitable conduct of its business, and it shall be authorized to buy and sell all material for the purpose of wholesaling and retailing the same.

3. This corporation shall have all the powers, general or specific, specified, granted to or conferred upon corporations for

profit under the provisions of Chapter 607, Florida Statutes, and all of the laws which are amendatory and supplementary to such law. The enumeration of specific powers herein shall in no way limit or restrict this corporation in the exercise of such powers.

ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at one time is 10,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV

This corporation is to exist perpetually.

ARTICLE V
