T. Christopher Bosso - 100 shares

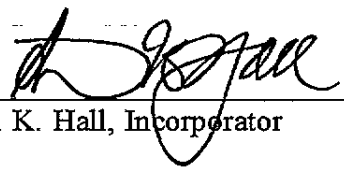
ARTICLE XI - INDEMNIFICATION
