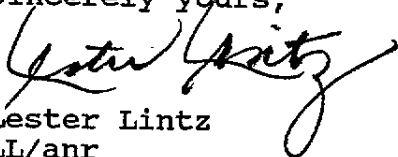

**Article X - Indemnification**

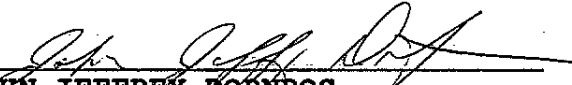
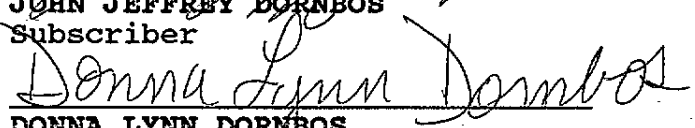
The corporation shall indemnify any officer or Director, or any former officer or Director, to the full extent permitted by law.

amendment hereto, and any right conferred upon the Stockholders is subject to this reservation.

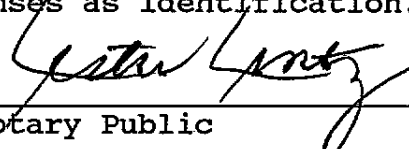
