# ARTICLES OF INCORPORATION OF

VENEZIA TWIN CENTRE, INC.

The undersigned subscriber to these Articles of Incorporation does hereby form a corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes.

# ARTICLE I

## NAME OF CORPORATION

The name of this Corporation shall be VENEZIA TWIN CENTRE, INC.

## ARTICLE II

# GENERAL NATURE

The general nature of the activities of this Corporation shall be the leasing and management of commercial real estate and the transaction of any or all lawful business for which corporations may be incorporated under this Chapter 607 Florida Statutes.

# ARTICLE III

# CAPITAL STOCK

- A. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred Thousand Shares (100,000) of Common Stock having a par value of One Dollar (1.00) per share, which shall be with preemptive rights.
- B. - c. Notwithstanding the foregoing, the Corporation shall have the right to increase its capital stock either with or without par value and to provide in the event of such increase the designation, preferences, voting powers or restrictions or qualifications of voting powers, of such additional stock in an amendment to its Certificate of Incorporation.
  - D. There shall be preemptive rights.


