Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida corporation adopts the following articles of amendment to its articles incorporation:

**FIRST: Amendments adopted:**

(1) Article I of the Articles of Incorporation shall be changed to reflect the new name of the corporation to:

**Army/Navy Fashions, Inc.**

(2) Article III shall be changed to reflect the purpose of the corporation which is:

**The general nature of the business to be transacted by this corporation is as follows: To engage in the retail sales business of buying and selling those products associated with U.S. Army/Navy military type styles and any other business permitted under the laws of the United States and the State of Florida.**

(3) Article VII shall be changed to reflect the new address for the principal corporate office address as well as the address for the corporate registered agent which is:

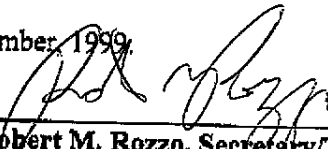
