ARTICLE 2- PRINCIPAL OFFICE

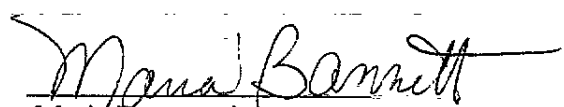

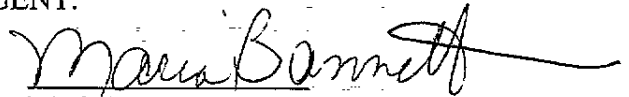
