Pursuant to our conversation this afternoon, and on behalf of our client TechHealth, Inc., we respectfully request that you waive reinstatement for this entity based on the foregoing. As we discussed, in July of 2000, our client filed its 2000 Uniform Business Report simultaneously with that of AccessLife.com, Inc.'s filing. They filed these applications with one check for \$1100, covering both of the late filing fees of \$550 per entity. However, it appears that the Department inadvertently credited the full \$1100 payment to the AccessLife.com account rather than applying the payment equally among the filings. Hence, only AccessLife.com's filing was accepted but the entire \$1100 payment was applied in error to the AccessLife.com account. Although the Department issued a rejection of TechHealth's filing for failure to pay its fee, our client never received that rejection letter, and subsequently, TechHealth, Inc. was administratively dissolved. Therefore, as per our conversation, we respectfully request you waive reinstatement for TechHealth, Inc. and apply the \$550 overpayment made to AccessLife.com, Inc. to the TechHealth, Inc. 2000 Uniform Business Report as filed with your Office in July of 2000. We appreciate your consideration and cooperation in this matter.
