ARTICLES OF INCORPORATION  
OF  
VIACORP MARKETING COMMUNICATIONS, INC.

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the laws of the State of Florida; as follows:

1. NAME

The name of this corporation is:

VIACORP MARKETING COMMUNICATIONS, INC.

2. TERMS OF EXISTENCE

The date when the corporate existence shall commence shall be the date of filing of these Articles of Incorporation, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

The purpose for which this corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws, including the ownership and operation of real property.

4. CAPITAL STOCK

The corporation shall have the authority to issue 1,000 shares of common stock, in one class only, each with a par value of \$1.00.

The initial Board of Directors shall consist of one member whose name and address is as follows:




