ARTICLE I – NAME

The name of this corporation is HOT SHOT AMUSEMENTS, INC. The address of this corporation is 2006 SYKES CREEK DRIVE, MERRITT ISLAND, FL 32953.

ARTICLE II – DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be SEPTEMBER 1, 1999.

ARTICLE III – PURPOSE

This is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

## ARTICLE X – COMPENSATION OF DIRECTORS


The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation.
