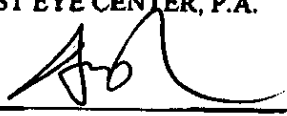

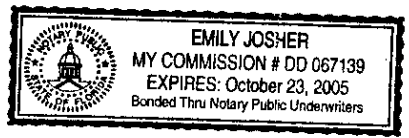
1. Steven Bovio, O.D. is the President of GULF COAST EYE CENTER, P.A., a Florida corporation, (hereinafter "Corporation").
