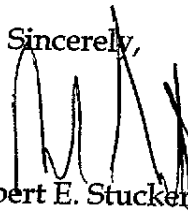

ARTICLE I - NAME

The name of this Corporation is: SCISSOR TIME, INC.

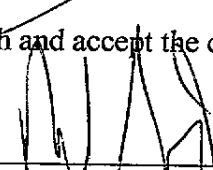
