**ARTICLES OF INCORPORATION
OF
JR's TRANSMISSION SERVICE, INC.**

The undersigned incorporator hereby adopts these Articles of Incorporation for the purpose of forming a corporation (the "**Corporation**") under the Florida Business Corporation Act (the "**Act**").

**I.
Name**

The name of the Corporation shall be **JR's Transmission Service, Inc.**

**II.
Term of Existence**

The Corporation shall begin its existence on the date of the filing of these Articles of Incorporation with the Florida Department of State, and it shall have perpetual existence thereafter.

**III.
Purpose**

This corporation is formed to engage in (i) consulting and related activities which are related, directly or indirectly, to servicing motor driven vehicles and (ii) any activity or business permitted under the laws of the United States and the State of Florida.

**IV.
Principal Office**

The street address of the initial principal office of the Corporation shall be:

**V.
Capital Stock**

The Corporation shall be authorized to issue 100 shares of common stock having a par value of one dollar (\$1.00) per share.

VI.
Initial Registered Office and Agent

VII.
Directors

The Corporation shall have one director initially. The number of directors may be increased or decreased from time to time by the bylaws of the Corporation, provided that the Corporation shall always have at least one director. The power to adopt, alter, amend or repeal bylaws shall be vested in the Corporation's Board of Directors.

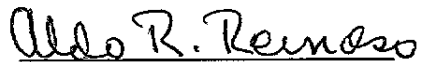

These Articles of Incorporation may be amended in the manner provided by law.

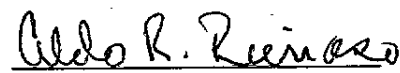
