ARTICLES OF INCORPORATION

OF

RDT PROPERTIES, INC.

The undersigned subscriber to these Articles of Incorporation being a natural person, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

The name of the corporation is: RDT PROPERTIES, INC.

The general nature of the business to be transacted by this corporation is to engage in the business of a real estate investment business.
