ARTICLES OF INCORPORATION

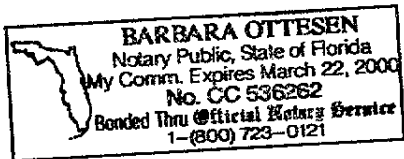
